THE COUNCIL OF SUPERIOR COURT CLERKS WAS CREATED BY LEGISLATIVE ACT IN 1990.

THE COUNCIL'S PRIMARY PURPOSE IS TO ASSIST SUPERIOR COURT CLERKS THROUGHOUT THE STATE IN THE EXECUTION OF THEIR DUTIES AND TO PROMOTE AND ASSIST IN THE TRAINING OF SUPERIOR COURT CLERKS.

THE COUNCIL PUBLISHES A PERIODICAL CALLED "THE RECORD". IT IS A PUBLICATION BY CLERKS, FOR CLERKS AND ABOUT CLERKS.

OUR MOST IMPORTANT PROJECT FOR THE PAST TWO YEARS HAS BEEN PURCHASING AND PROVIDING SETS OF THE OFFICIAL CODE OF GEORGIA ANNOTATED FOR THOSE CLERKS WHO DO NOT HAVE ACCESS IN THEIR LOCAL OFFICES. TO DATE, THE COUNCIL HAS PURCHASED 35 SETS, AND HAS ORDERED 10 MORE SETS THIS YEAR, TO COMPLETE THE PROJECT.

### **THIS YEARS PROJECTS INCLUDE:**

DEVELOPING A SUPERIOR COURT CLERKS MANUAL WHICH WILL BE UPDATED ANNUALLY AND TO PROVIDE TRAINING TO NEWLY ELECTED CLERKS BEFORE TAKING OFFICE. THIS MANUAL AND TRAINING IS SCHEDULED TO BE AVAILABLE FOR NEW CLERKS WHO ARE ELECTED IN 2000;

DEVELOPING A UNIFORM PROCEDURE FOR THE DISTRIBUTION OF FINES AND FORFEITURES. THIS COMMITTEE IS WORKING IN CONJUNCTION WITH THE GEORGIA COURTS AUTOMATION COMMISSION AND THE ADMINISTRATIVE OFFICE OF THE COURTS;

DEVELOPING, DESIGNING AND INSTALLING A WEBSITE WITH INFORMATION ABOUT THE CONSTITUTIONAL OFFICE OF SUPERIOR COURT CLERK;

WORKING WITH THE SUPERIOR COURT CLERKS' ASSOCIATION TO DEVELOP A STRATEGIC PLAN AND LONG RANGE GOALS FOR SUPERIOR COURT CLERKS;

IT HAS BEEN MY PLEASURE TO SERVE AS PRESIDENT OF THE COUNCIL OF SUPERIOR COURT CLERKS THIS YEAR AND I APPRECIATE THE TRUST THE COUNCIL HAS PLACED IN ME.
