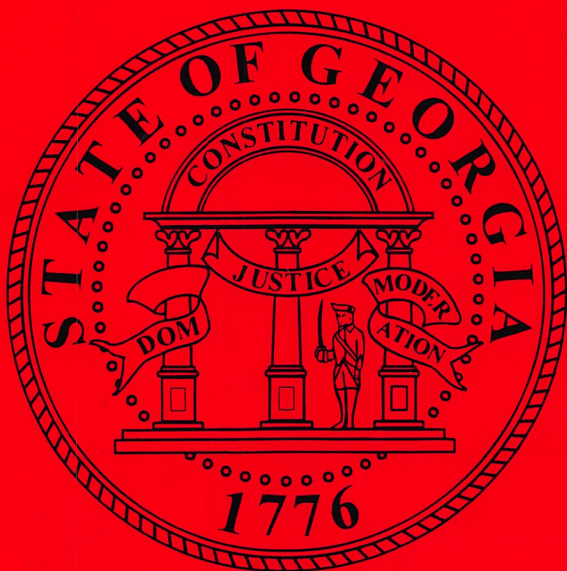

The Council of Superior Court Clerks of Georgia was created by Legislative Act in 1990. The purpose of the Council is to further the improvement of the Superior Courts and the administration of justice, to assist the Superior Court Clerks throughout the state in the execution of their duties, and to promote and assist in the training of Superior Court Clerks.

The Council serves as liaison for all clerks in working with other members of the Judicial branch, law enforcement and prosecution, as well as entities at the State and Federal levels to facilitate the efficient and effective compliance and execution of the duties required of the Clerk of Superior Court as they relate to these entities.

This year, the Council has obtained grant funds to provide case management systems for judicial records in any Superior Court Clerk's office that is presently non-automated. Grant funds have also been obtained to implement the statutory requirements mandated under Senate Bill 50 in the 2001 Legislative session that requires all Superior Court Clerks to electronically transmit certain records to the Georgia Crime Information Center and to the Georgia Courts Automation Commission.

The Council, in conjunction with the Superior Court Clerks' Association and Training Council, assisted in providing the first mandatory 40 hour training session for newly elected clerks prior to their taking office January 2001. The additional training for all clerks and the implementation of training sessions for staff personnel is an ongoing priority for the Council.

Permanent projects of the Council include updating of the Clerks' directory, and the full time commitment to developing and updating the Clerks' Reference Manual that is distributed on CD-ROM to all Superior Court Clerks' offices.

It is a privilege and a pleasure to serve as President of the Council of Superior Court Clerks. I appreciate the trust and the cooperation extended to me by my fellow clerks. I am proud of the unity of the 159 Superior Court clerks and of the commitment made by each clerk to improve services, promote professionalism and implement statewide technological advances in each office.
