

# COUNCIL OF SUPERIOR COURT CLERKS OF GEORGIA FROM THE PRESIDENT

Frank Abbott Superior Court Clerk Lamar County, Georgia

A Legislative Act in 1990 created the Council of Superior Court Clerks of Georgia, which has a three-pronged mission. First is the overall improvement of the Superior Courts, second is to offer aid to all Superior Court Clerks throughout the state in the successful completion of their functions, and third is to provide the required level of training so as to insure the highest quality of service possible.

As the liaison for Superior Court Clerks to law enforcement, prosecution, and other areas of the judicial branch, as well as state and federal departments, the Council's objective is to coordinate and facilitate the efficient and effective execution of related duties involving all of these entities. To this end, on January 1, 2005, the Council contracted with Mike Holiman to act as its administrator. Mike is a tremendous resource and asset for our association.

Because of the 2001 grant funds that were obtained so that the Council could provide for a civil and criminal case management system, all Clerks now meet the requirements of Senate Bill 50. All Clerks can electronically transmit civil and criminal record to the Clerks' Authority, and the criminal records are disseminated to the Georgia Crime Information Center (GCIC). On January 1, 2004, plats and liens were added to the data base at the Clerks' Authority to be accessed in the same manner as UCC and real estate records. And, as of November 2004, all real estate transfer tax forms (PT-61's) are e-filed in Georgia.

Training for newly elected Clerks was a major concern for the Council prior to the year 2001. Joining with the Superior Court Clerks' Association, the Council implemented a mandatory forty hour training session. With a great success, the second session was completed in November 2004. As always, continuing education and training for all Clerks and staff personnel will remain of the highest importance for the Council. In this regard, the Clerks' Reference Manuel and its updating will continue to be a permanent project as well as the Clerks' Directory.

A special thanks to past President, Connie Cheatham, for her tireless leadership and unwavering commitment.

There will no doubt be new and challenging items placed before us in the coming years. These challenges will require the creation of new capabilities for us – however, there exist no challenge too great for us. The strength and unity of purpose within our association, the leadership, and the quality of our people cannot be defeated. It is with deep humility that I look forward to service as your President.
